We will take your application into the American Embassy and apply for your visa. All applicants will be required to have a personal interview with the US Embassy, in following weeks. You will receive your passport and visa from the CCUSA office on May 14<sup>th</sup>, 2017.
- 4) After you are hired, **go and get your Police Check (Hatósági Erkölcsi Bizonyítvány)** from your local post office, it will cost about 3,100 HUF. Please fill it out for all categories. Once you receive it from the Ministry, you <u>must provide a copy of it right after your placement</u> and **take the original with you to camp**. If this document not received by May 14<sup>th</sup> 2017 you will incur a non-refundable €25 sub-charge.
- 5) On **Sunday, May 14<sup>th</sup>, 2017**, we will have the **Final Orientation Meeting** in the Budapest office. You are required to attend this meeting! <u>If you don't come, your visa will be cancelled</u>. You will meet all the other participants who are going to the States this summer, and we will give you last minute information on visa rules, changes, flights and insurance updates.
- 6) Please remember that after you got your visa, and before you leave to the States in June, you have to book your flight for yourself and upload ALL flight information to your Footprints account and email  $\underline{\text{weusa@ccusa.hu}}$  so that we can set your insurance dates. If this is not done by May 14<sup>th</sup> 2017 you will incur a non-refundable €25 sub-charge.
- 7) You are responsible for all travel costs associated with getting to your work site, and all living expenses throughout the summer. Thus, you should arrive with no less than \$1500 USD available on a credit card and also some cash.
- 8) You **MUST validate your visa** as soon as you have entered the United States and do a **check-in every 30 days**. Failure to do so can result in automatic termination of your visa! You are only able to work during the dates that are available on your Footprints, at the visa section. After you finish working, you have some free time to travel around the US! You must leave the US and be back home for the FIRST teaching day!!! You are responsible for all costs associated with this, including the extension of your insurance (3,2€/day Economy). The insurance valid only for 3 months, starting on the day of your departure.
- 9) At the end of your travels, when you fly back to Budapest and return home, you MUST send us your Return Flight Boarding Pass and your DS-2019 Form. We have to return these to the American Embassy, to prove that you have returned home to Hungary. If you don't, we must report you to the Embassy as "missing" and in violation of your visa.
- 10) Please read through the **Program Agreement** for all details concerning the **30-day check in**, the Refund Policy if you need to cancel from the program prior to your departure to the US. If you have any other questions regarding any of the above information, or anything else about the program, please contact me immediately. Until then, take care and start preparing for the **Best Summer of Your Life!**
