# INTERN IN THE USA



## ★☆☆ PRACTICAL TRAINING USA

Practical Training USA is designed to allow foreign professionals to come to the United States to gain exposure to U.S. culture and receive training in U.S. business practices in their chosen occupational field. Departure are year round and the visa can be from 3 - 18 months in length.

You must have a degree or professional certificate from University, College or TAFE and at least one year of prior related work experience in your occupational field outside the United States OR five years work experience in the occupational field.

## ★☆☆ INTERN USA

Intern USA is designed to allow university, college or TAFE students or recent graduates to come to the United States to gain exposure to U.S. culture and receive hands-on experience in U.S. business practices in their chosen occupational field. Departure are year round and the visa can be from 3 - 12 months in length.

You must be currently enrolled in and pursuing studies in a foreign degree or certificate-granting post-secondary academic institution, outside the US, and taking an approved gap year off (University documentation required); OR have graduated from such an institution no more than 12 months prior to your internship program start date.

## ★☆☆ WORK CATEGORIES

These programs are year-round, and you may work in any state, on a CCUSA approved training or internship program, in the following occupational categories:

- Hospitality and Tourism (maximum of 12 months)
- Information Media and Communications
- Management, Business, Commerce and Finance
- The Sciences, Engineering, Architecture, Mathematics and Industrial Occupations

We typically require at least two months before you wish to begin your training program, to allow for interview and visa processing time. Sometimes the process can take longer as your host company works on a viable training plan

## ★☆☆ PROGRAM OPTIONS

### Independent Option

You are responsible for finding a host company to offer you a training program in one of the approved categories. Once a company is located and the information given to CCUSA, we will contact the company to verify their suitability. We will review their obligations and determine if the training program meets the appropriate requirements.

### Placement Option

With the placement option, you would apply for one of CCUSA's approved Training or Intern programs with our list of employers. You would submit your CV/Resume, completed application including references along with the placement fee. If accepted to the program, CCUSA will forward your application to the host company and the host company would set up an interview. If you are offered the training program, CCUSA would sponsor you and guide the host company through the visa process.





## ★☆☆ PLACEMENT EMPLOYERS

## ★☆☆ ELIGIBILITY

There are a number of requirements for you to be eligible for these programs and the visa. Ideally you will have a degree/certification or be a current student in the field you are seeking to participate in. For the Intern program, you can only participate within 12 months of graduating.

For the Practical Training program, if you do not have a degree, 5 years work experience in the field may suffice.

## ★☆☆ APPLICATION PROCESS

To apply, you will need to submit the following:

1. [Click here](#) to apply.
2. Create your interactive personal account and start your application form.
3. Submit your Resume/CV so we can confirm your eligibility
4. Complete the remaining documentation, signed Program Agreement, 2 x References, University documentation or work proof, Application Video, Program fee.
5. CCUSA will arrange a personal interview with you to find out more about you, your skills and experience.
6. Once accepted you complete a Health History Form and Federal police check .
7. Once your placement is confirmed CCUSA will issue you with the Visa sponsorship forms.
8. CCUSA will assist you with visa process and direct you to our suggested travel agent for your travel needs.

It's that easy!

You will also need to apply for the visa to allow you to work legally in the USA. As your visa sponsor CCUSA will assist you through this entire process and our experts will guide you through every step.
